1.	<p>APOLOGIES FOR ABSENCE: Apologies were received from Cllr P Flynn, Cllr E O'Regan and Cllr N Webb,</p>	
2.	<p>DECLARATION OF INTEREST IN AGENDA ITEMS: No items were declared.</p>	
3.	<p>MINUTES OF THE PARISH COUNCIL MEETING OF 15TH OCTOBER 2013: The minutes were agreed and signed as a true record.</p>	
4.	<p>MATTERS ARISING: There were no matters arising not on the agenda.</p>	
5.	<p>COUNTY COUNCIL AFFAIRS: Cllr Topping attended the meeting and gave the following report:</p> <p>"County councillor's report <i>Speeding in the village:</i> <i>I contacted David Lines, who is now the best person to talk to regarding these matters, rather than Mike Cooper, following the re-organisation of the highways dept.</i></p> <p><i>David Lines indicated that any further speed limiting proposals would need to be run past the police who would want to understand the scale of the issue - and commitment required in terms of enforcement - before supporting any proposals. This would usually be in the form of a speed survey.</i></p> <p><i>I went through the helpful Sgt Sandra Davidson at Sawston to the County police traffic officers.</i></p> <p><i>They have advised they could not do a survey this side of Christmas, and commented:</i></p> <p><i>"As and when a survey is arranged, we may supply a summary of results which is free. A full report is £300 per box and @£150 for each one thereafter. Due to the high demand of requests such as these, some justification is also sought. By that I mean the local officer or PCSO conducting a 100 vehicle silent (covert) radar check to identify if there is a particular issue in any case. That at least gives a good indication and start off the process. The P Council could also request this be done by Cambs County C. and throw in a 'bid' so that the highway authority promotes the traffic order as well - which they must do in any case and be supported by them. Is there a collision history here that is speed related and what (if any) other measures are proposed to encourage compliance ?</i></p> <p><i>My suggestion is that (a) the parish asks their sector police to conduct the silent survey</i></p>	

	<p><i>described above to assess the situation (the PCSOs can do this). (b) the parish uses the local traffic initiative bidding process - bids have to be in by 4th December - to apply for a 20mph zone in the village (c) we need to understand the history - though it isnt always the case that there has to be a history of collisions and accidents for improvements to be made.</i></p> <p><i>Tunnel effect issue:</i> <i>I cant get David Lines to the parish council meeting, but I have discussed with David a site meeting to review the tunnel and its effects on the road at the centre of the village - I suggest that the parish clerk fixes the date with David and whoever else needs to be there. I can be there but it would have to be a Friday, or at a pinch a Tuesday.</i></p> <p><i>Dottrell Hall</i> <i>I have also chased up the enforcement re Dottrell Hall. County replied:</i></p> <p><i>As a significant volume of wood waste remains on the land the landowner has been advised in writing that the County Council intends to prosecute the matter through the courts. The case file has been largely completed and passed to the legal team for consideration. A summons will be issued once legal are satisfied that sufficient evidence has been provided to secure a conviction and that prosecution of the landowner would be in the public interest.</i></p> <p><i>I spoke to Andrew Greenwood about progress. A site inspection with a surveyor (Mr Green) is taking place today. I will advise at the meeting as getting to be sub judice. Andrew has offered to call Cllr Roberts to explain. Environment Agency involved. "</i></p> <p>Clerk to write and express their dismay at the lack of progress of the alleged offences at Dottrell Hall and ask for the date when the legal work will be complete - via Cllr Topping.</p> <p>Clerk to progress the issue of the tunnel after Christmas and keep Dr Howe informed. Clerk to ask the Police to conduct the silent survey.</p> <p>Cllr Topping said that the site (Dottrill Hall) was reviewed today and the expert opinion will provide details of the costs of removal, which should counteract any potential argument from the defendant - the legal process really is near completion - he is hopeful within the month.</p> <p>Cllr Topping said a bid really needs to go in by 4th December (he will send the contact at the police who needs to conduct the silent survey). Clerk to send through details of the bid initiative to all Cllrs.</p>	<p>Clerk</p> <p>Clerk</p> <p>Clerk</p>
6.	<p>TRAFFIC IN FOWLMERE: This item will be updated at the December meeting, following the input from Cllr Topping.</p>	
7.	<p>UPDATE ON THE VILLAGE HALL Cllr Roberts asked that the meeting is opened to the Chairman of the VH Committee. Cllr Roberts gave a summary of the background of the problems with the Social Club, which has been documented in previous minutes.</p> <p>Mr Bates said that a version of the agreement between the VH and the Social Club had been 'signed' with changes which the VH Committee could not agree to. Since then, there has been very little progress and the latest document has not been returned and the SC has</p>	

	<p>accumulated debts in excess of £2500. On the basis of that, the VH Committee decided to bring the matter to a conclusion as the SC is in breach of agreement in several ways. Cllr Bates read out the latest correspondence which will be held on the PC Notice Board too.</p> <p>The Social Club have been sent the letter via various means, including Recorded Delivery. Mr Bates has received an e-mail which shows that the Chairman has resigned, giving a weeks notice.</p> <p>Mr Bates seeks the support of the PC to take the situation further with a Solicitor (Hewitsons, Newmarket Road, Cambridge) and help financially. Recent fundraising events reflect the ongoing commitment of those on the VH Committee who are doing their absolute best to support the VH. The situation with the Social Club cannot be allowed to continue as it breaches Charity Commission rules.</p> <p>Cllr Roberts commended Mr Bates for his and the efforts of the Committee to try and resolve this situation. In principle, the PC can help financially and fully support the action taken. Cllr Roberts suggests that the PC agree to pay half of the cost, up to a total of £200 from the PC, Cllr Peacock proposed, Cllr Bottrill seconded and all agreed to this. This is reasonable to get the action going.</p>

Fowlmere PC considers that it is wrong to give approval to such sites. There is a significant underground 'flow' of water here which could have a serious impact on neighbouring properties. The residents in the neighbouring houses to this site have been put through a very long and miserable time because of the protracted attempts at remedial work, and the Parish Council considers that the planning authority has a duty of care to these people. They should not be subjected to further noise, dirt and vibration

in the attempt to develop an unsuitable site.

	<p>B) GREEN LANE</p> <p>The Clerk read out an e-mail from Cambridge Road residents who live along the side of Green Lane where work is being done to the road which has removed their grass verge and is turning the road into a mud-bath. The PC cannot do much about replacing the verge or cleaning the wall as this needs to be resolved directly with the landowner (Clerk to advise). It does however raise questions about how the track is being used. Ion Science use this access for several spaces, separately to their main parking space.</p> <p>Clerk to ask SCDC if Ion Science have to exclusively use The Way, under their planning conditions. Also it is a potential blind entrance, so Highways may need to be involved. Clerk to also ask Cllr Topping to ask CCC to look at it from a traffic perspective, as it is lorries as well as cars using the lane. It was very difficult for the residents at Sparrows Lodge to pass down the lane, which turned into a mud-bath in the bad weather.</p> <p>The Meeting was then opened to members of the public.</p> <p>Mr Lester (a Fowlmere School Governor) attended the meeting to make the PC aware that the school were approached by County with a sum of money to create a 'teaching space' - so he is notifying the PC that a planning application will be imminent and would welcome the PC support.</p> <p>Cllr Roberts asked if it's a listed building (it is) and checked they have been speaking to the Conservation Dept at SCDC. If the Conservation Dept aren't happy, they will refuse it so she urged them to work in tandem to reach agreement. Mr Lester said that David Easthope has been helpful with advice. Cllr Roberts said that as a PC, we cannot give an opinion until an application has been seen but thanked him for the information. Cllr Roberts, as District Cllr will ask Conservation to help the school by suggesting what they need, with some speed.</p> <p>Mr Nolasco would like to raise the subject of the ditches in the village. The risk of flooding is considerably increased because the ditches are appearing as blocked and in a bad state of repair, and the PC should lobby SCDC or landowner to undertake the work. The PC should also set aside a sum of money to undertake this work if it is not done properly.</p> <p>Cllr Roberts said the PC do not have ownership, therefore responsibility and SCDC have responsibility for the Wallington Brook, the only adopted watercourse.
